The organization's goals are to provide the opportunity for preschool age children from low-income families to gain experience and competence to enable them to participate more fully in subsequent public education, have needs met that all children share but that low-income families have great difficulty meeting, help develop a greater degree of social competence for children of low-income families, and broaden the experience range of families as a whole to improve family success opportunities. The program served 370 children and families during the fiscal year.
