This school, like the other Hand in Hand campuses, will grow year by year into a full-fledged elementary school. Funds supported the growth of Hand in Hand's school in Tel Aviv into first grade, growing from 95 pupils the previous year to 171 pupils in 2015-2016. Hand in Hand's community programs grew to include 6,000 Jewish and Arab adults who participated in joint community programs and activities. Hand in Hand graduated its sixth 12th grade high school class.
