The mission of St Francis Center is to feed, serve, and walk with the poor as a community of hope in the spirit of St Francis of Assisi

St Francis Center's Family Well Being Program provides vital services for extremely low income families in Los Angeles including pantry services, resource services, case management, emergency shelter, rental and utilities assistance, summer youth programs, holiday programs, and health care services. In 2016 they expanded their service area and brought multiple mobile food pantries to neighboring communities affected by food insecurity. Their strategic corporate partnerships with food based businesses enabled their team to recover over 1.2 million pounds of food, providing 16,836 grocery visits for families living below the federal poverty level. Their efforts inspired over 3,500 volunteers to donate over 20,000 hours of service to help facilitate their programs. The St Francis Center's efforts have helped to create a safety net for families living in poverty to avoid homelessness. Workshops provided through the Center's resource services for families were instrumental in educating and empowering the local community and included topics on financial literacy, immigration, health and wellness, and nutrition.

4b (Code) (Expenses \$ 820,227 including grants of \$ 558,856) (Revenue \$)

St Francis Center's Homeless Well Being Program provides a number of services for homeless individuals and families including morning meal services, case management, emergency shelter, transitional housing, resource and referral services, health and hygiene services, showers, mail services, computer and phone access. These program offerings helped improve the overall health and stability of the homeless community while inspiring change and hope. In 2016 they built upon their strength in hunger relief services and provided transformational change for their guests through a case management services model focusing on housing and referral services. The Center's primary service area is the highest in the country and last year saw as much as a 44% jump in homelessness in neighboring communities. Strategic partnerships with businesses, other nonprofits, and city and county leaders have enabled St Francis Center to keep up with the growing demand for their services. In 2016 they served over 100,000 meals, almost double from five years ago and implemented much needed housing and case management programs.
