Operating expenses and revenue for OGA during the fiscal year ending September 30, 2016 were \$11,668,804 and \$8,538,488, respectively. Operating expenses and revenue for WMC during the fiscal year ending September 30, 2016 were \$7,007,807 and \$5,489,061, respectively. The CVI was created in an effort to meet the demands of the changing health care environment and to enhance the level of cardiovascular care provided to the community. CVI includes approximately 55 cardiologists along with support staff at three ambulatory care centers and two comprehensive cardiac centers. This innovative program brought together the well-known cardiac programs of both RIH and TMH and places a stronger emphasis on extending these programs into the community, where it is more convenient for patients to receive care. The LPG portion of CVI's program expenses consists primarily of CVI's expanded office-based services.
