	The goal of The Bowery Mission (CHA) is to be the most effective provider of compassionate care and life transformation for hurting people in New York City. Since 1879, The Bowery Mission has provided a holistic pathway out of homelessness as well as compassionate care to anyone in need. We are on a mission to rebuild hope. We accomplish this through three major strategies: Compassionate Care, Adult Life Transformation Programs, and Children and Youth Programs. Compassionate Care: The Bowery Mission's compassionate care program offers comprehensive services to meet the basic needs of anyone who comes through our doors, every day of the week, no questions asked. As many as 10,000 individuals rely on our services annually. In 2016, our compassionate care program provided 505,000 meals, 56,200 clothing items, 13,900 showers, 708 medical exams, 97,300 nights of shelter, and 211 crisis intervention referrals. Meals are offered three times a day, every day of the year, with a dedicated kitchen staff and thousands of volunteers each year. The Bowery Mission recently opened a 40-bed short-term men's shelter program at our location at 227 Bowery. Including showers, hygiene items, clean clothes, linens, and brand-new donated mattresses, the shelter program provides services in a dignified setting. In 2016, we served 582 men in our 21-day shelter. Medical care is provided once a week by a team of volunteer doctors and nurses. In the summer of 2016, thanks to a \$800,000 gift from a donor, Goodwill Rescue Mission of Newark, NJ, joined The Bowery Mission to form a larger organization serving the greater New York City Area. Joining forces with Goodwill Rescue Mission allows us to better support the homeless in Newark with resources in Manhattan as well as New Jersey. Through this new strategy, Goodwill Rescue Mission will continue to be a hub in Newark for Compassionate Care including warm food, showers, clean clothing, and overnight shelter. The Bowery Mission's recent expansion to East Harlem uncovered new partnerships and new needs in a neighborhood where unemployment, poor education and legal trouble is the norm. With a number of community partners now operating under The Bowery Mission roof, we offer neighbors a walk-in resource center - the Community Hope Resource Center - where they can easily access services and navigate the process with bilingual advocates who guide them to their desired goals for education, health, legal assistance or vocational success. We expect to serve 450 individuals in 2017 Adult Life Transformation Programs. While meeting basic needs is crucial, our ultimate goal is life transformation. Each of these services are intended as an invitation for men and women in crisis to leave the streets for good by entering one of our long-term residential Life Transformation programs. These programs are located in the Lower East Side, Upper East Side, Central Harlem, and East Harlem, for a total of over 250 beds. The goal of these programs is to empower men and women in crisis to permanently overcome homelessness, poverty, addiction, trauma, and unemployment. Residents typically stay between 6-15 months and receive free food and housing combined with spiritual discipleship, addiction recovery, clinical counseling, life skills training, and career training. Once residents gain employment, they can stay until they have saved enough money to move out to independent living. Residents are placed in jobs and housing with the assistance of counselors and Career Center staff. Our program is unique in its holistic focus on the recovery of the entire person, with a strong emphasis on spiritual, emotional and psychological as well as physical and economic recovery - which translates to long-term change. In 2016, The Mission served 281 men and women in our recovery programs. Of these, 115 secured housing and 111 gained employment. 61 graduated from the program having achieved all of our proven indicators of future success: 1) Have a stable income and a place to live, 2) Are committed to sobriety, 3) Have established healthy relationships, 4) Are spiritually grounded, 5) Have a plan for the future. Alumni programs and the Community Hope Resource Center continue to support our graduates after they have left The Bowery Mission.

Children & Youth Programs Our children's programs include Mont Lawn City Camp and Summer Camp, two arms of one program intended to provide support for underprivileged children from New York City -- with the goal of helping to prevent the cycle of homelessness from starting. Our programs emphasize strong values, healthy relationships, skill-based learning, and strategies for making good decisions. City Camp provides year-round mentoring and enrichment programs (such as art, creative writing, running, and soccer) with locations in the South Bronx and East Harlem. These programs happen weekly on a seven-week cycle. At Mont Lawn Summer Camp, kids from NYC - many of whom have never set foot outside the city - spend a week in the Pocono Mountains engaging in skills-based activities, play, small-group learning, and mentoring. In 2016, we served 169 children across both our South Bronx and East Harlem City Camp sites and 1,005 children at our summer camp.
