The portfolio provides housing for qualifying families, seniors, and people with disabilities. The portfolio consisted of 84 affordable housing communities comprised 3,361 units that provided high-quality, affordable homes for 7,812 residents. The portfolio paid \$2,244,946 in property taxes to municipalities and has rental
