SINCE THE INCEPTION OF THE COMPANY IN 2005, 367 BUSINESSES HAVE BEEN ASSISTED IN THE GREATER HOUSTON AREA AND THROUGHOUT TEXAS AND LOUISIANA. OVER 570,000,000 IN BUSINESS FINANCING HAS BEEN PROVIDED SINCE INCEPTION THROUGH 504 AND RELATED PROGRAMS INCLUDING THE PARTICIPATION OF TEXAS LENDING INSTITUTIONS. 3400 JOBS HAVE BEEN CREATED DURING THAT TIME.
