

Most of the money we raise goes directly to pay school fees and school expenses for orphans and vulnerable children in Zimbabwe.

In total, we funded 40 students in 2016. Of these, 19 attend local schools (\$23,131), 8 attend technical schools (\$26,449), 12 attend boarding school (\$236,350), and 1 was in university (\$2,436). We also spent \$11,284 for medical fees, tutoring, prizes for outstanding academic achievement, award dinners, sports programming and emergency food packs. In total, we spent \$99,650 on grants.

990EZ - Part I, line 16: Other expenses

This year we spent \$3,444 on bank and wire transfer fees, \$10 on phone calling cards, \$184 on taxes and filing fees for Attorney General forms, \$5,318 on travel to Zimbabwe and board meetings, and \$291 on website maintenance. In total, our administrative fees were \$9,247.
