1) ScaleUp West Virginia Program Through its ScaleUp West Virginia program, which included services delivered by five sub-awardees, TechConnectWV assisted 55 entrepreneurs and existing companies in creating new products, processes and strategies and helped in the creation of 12 new companies, which resulted in the creation of 13 new jobs and 28 jobs retained. In addition, the ScaleUp WV program assisted in the creation of nearly 30 new products and processes and leveraged \$660,000 in follow-on funding through venture capital and matching support from other economic development organizations. The ScaleUp WV program also offered training to more than 120 individuals in how to apply for, and win, awards through the federally-funded Small Business Innovation Research and Small Business Technology Transfer programs. Program serves 250 people

TechConnect hosted forums and special events designed to raise awareness of the benefits of tech-based economic development, spotlight success stories and share best practices, and encourage innovation and entrepreneurship throughout the state, including 1) Spirit of Innovation Awards, 2) Innovation & Entrepreneurship Day, 3) Growing Innovation in the Mountain State featuring Intuit CEO Brad Smith, 4) West Virginia's Innovation Economy Quantified, a panel at the WV Chamber of Commerce Annual Business Summit. In addition, TechConnect co-hosted events designed to spur cluster growth in key technology sectors, including the 2015 TransTech Energy Business Development Conference and the 2016 West Virginia Bioscience Summit. These programs served 475 individuals
