Catherine McAuley MERCY Foundation helps to provide the financial resources for Sisters of Mercy Services Corporation (SOMSC), Sisters of Mercy Urgent Care (SOMUC) and other organizations identified and associated with these organizations important work. The Foundation, which is the fundraising arm of SOMSC/SOMUC, helps purchase medical equipment for our urgent care facilities as well as send relief teams and supplies to Haiti through our International Medical Mission outreach program.

During Fiscal Year 2016, the Foundation directly contributed \$5,792 to Frances Warde Family Health (FWFH), our primary care practice within SOMUC to help provide free or reduced care to uninsured patients through our charity care/community benefit outreach program.
Frances Warde Family Health (FWFH) provided care to 1,516 underserved and underinsured patients at our primary clinic located within our Brevard, NC Urgent Care Center.
During FY 16, the Foundation contributed \$21,311 to Brevard Urgent Care for purchase of a stretcher, vital signs monitor, piccolo analyzer and other equipment to help support the Urgent Care practice.
Brevard Urgent Care saw approximately 4,500 patients for FY16 at an average cost of \$138 per patient visit.

4b (Code:) (Expenses \$ 28,224 including grants of \$) (Revenue \$)
During FY 16, the Foundation supported SOMUC by providing \$10,417 funds that helped support collaboration with SOMUC and Mountain Area Health Education Center (MAHEC). MAHEC provided a sports fellow, specializing in orthopedic injury, at our Urgent Care Center for 8 hours a week for a year.
In addition, The Foundation supported the Council on Aging by contributing \$17,807 for the year to support staff in outreach efforts to the aging population in the Fairview /East Asheville area. Approximately 6 new clients were reached per month by this supported position.

During FY 16, \$44,224 of support was provided by the Foundation to directly support our international medical relief mission. 394 patients were seen during the two trips made during FY 16.
