 Prosthetics The Chapter picked up and delivered DME from donations across the state. These were distributed to Veterans, civilian individuals, and other non-profits for low income individuals. We also received and disbursed a large amount of medical supplies. We added multiple new agencies to our resource list including the Adult Diaper Bank from Glendale, AZ. These efforts were made possible by a generous grant from the Christopher and Dana Reeve Foundation.

 Education, training and outreach Sponsor of educational research and training opportunities for medical research on spinal cord injuries. The Chapter provided direct sponsorship to the Womans Veterans Booth at Stand Down at the Phoenix Fairgrounds. Over 175 Veterans were helped. We provided over 500 hours of volunteer hours at various community events such as the Veterans booth at the State Fair.
