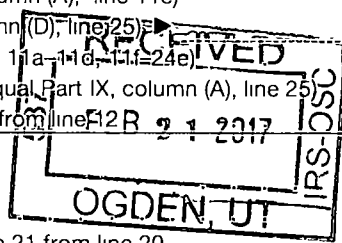

Food store. Therefore the donation of food is calculated as $\$2,750 \times 52 \text{ weeks} + \$2,770$ of extra food by SVPD members to total \$145,770

On average the food item donated has a retail value of \$5 Thus, $\$145,770/5 = 29,154$ pieces of food donated annually.
