DURING THE TRIP, CYCLISTS ARE EDUCATING COMMUNITIES AND SPREADING AWARENESS OF MULTIPLE SCLEROSIS IN PERSON, ON TELEVISION INTERVIEWS, NEWSPAPER ARTICLES, AND VIA SOCIAL MEDIA.
