Camp Breathe Happy
 38 Campers attended the 2016 Summer youth asthma camp. Children who attend District of Columbia residents, ages 8 to 12, actively struggling to manage their asthma. Campers and their parents complete a pre- and post-test to assess their asthma management knowledge, and parents complete a camp experience question questionnaire 60 to 90 days post-camp. Evaluation results show that Camp Breathe Happy was successful in reaching the goal to increase asthma knowledge and management skills. Participants significantly increased their understanding of various asthma related topics. The information gained through the program also led to observable improvements in asthma management, as indicated by parent responses

East of the River Tobacco Free Project
 With funding from the DC Department of Health, Breathe DC implemented the East of the River Tobacco Free project to reduce smoking in households with Children in Ward 7 and 8 communities, which have the District's highest smoking rates. The program served households with children by providing smoking cessation support, connection to local resources and offering home visits to reinforce new habits and improve the air that women and children breathe at home. Partnerships with the four Managed Care Organization (MCO) and United Medical Center resulted in reaching 640 smokers from priority populations, including 13 pregnant mothers to access the Quitline; Recruiting 71 smokers to participate in cessation groups; and enrolling 12 smokers to participate in text messaging.

Smoke Free Places
 Aimed at reducing exposure to secondhand and thirdhand smoke, and creating healthier living environments, in 2016 the smokefree places program educated 21 landlords and property managers at 2,544 housing communities with more than 7,632 tenants. The project disseminated cessation information, made referrals to cessation programs and educated landlords and tenants about the financial benefits of smoke-free housing.
