Through our Prayercast ministry (prayercast.com) we seek to mobilize prayer and develop media resources highlighting the needs of the world. Prayercast.com is regularly accessed by people from over 200 nations and all 50 states in the U.S. Churches and mission organizations use Prayercast videos to spark powerful times of corporate prayer. We seek to proclaim the gospel through our active interaction with our partner, OneWay Church, in ministering to people in the Aurora/Naperville area of western Chicagoland. We also partner with other ministries around the world to further the impact of local churches in their communities. OneWay produces and distributes music CD's with worship music to Christians around the globe, and each year ministers to hundreds locally through our annual "Shine" concert. The aim of the concert is to encourage people from various backgrounds, cultures and churches to come together and worship Jesus.

Our international ministries aim to partner cross-culturally with Christians living in other nations around the world. Our desire is to train Christian leaders and provide resources for gospel advancement globally. Our goal in Africa and other countries is to see national leaders rise up, be equipped, trained and set out to share the gospel with those who do not know about Jesus.
