Each year, hundreds of thousands of people are reached through the distribution of - Clothing, food, wheelchairs, and other items, which are distributed by School Without Walls (SWW) students and volunteers from local churches - In 2016, Mission Eurasia used our "I Care" Refugee Assistance Program to provide humanitanan aid for hundreds of thousands of refugees and other people in Ukraine who are suffering from the ongoing crisis in the nation - Gift of Hope boxes, which contain toys, sweets, and a children's Scripture piece, and our SWW students distribute during the Christmas season

School Without Walls/Next Generation Professional Leaders Initiative - These non-formal training programs are designed to train, equip and mobilize the Next Generation of Christian leaders in Eurasia to transform their nations for Chnst. Through SWW/NGPLI, young people receive biblically based training while participating in practical ministry outreaches in their communities. During 2015-2016, SWW trained a total of 1,489 students in 13 countries of Eurasia, and Israel, and NGPLI trained 7,185 young professionals from seven different countries. We estimate that more than 1.2 million people were impacted for Christ through this program in 2015-2016.
