THE BOARD OF DIRECTORS OF THE FOUNDATION HAS THE AUTHORITY TO VARY DONOR RESTRICTIONS IF CONTINUED ADHERENCE TO THAT RESTRICTION BECOMES UNNECESSARY, INCAPABLE OF FULFILLMENT OR INCONSISTENT WITH THE CHARITABLE NEEDS OF THE COMMUNITY SERVED BY THE FOUNDATION. THE ORGANIZATION MAY SUBMIT RECOMMENDATIONS REGARDING SPECIFIC PURPOSES OR AMOUNTS FOR DISTRIBUTION. THE BOARD OF DIRECTORS OF THE FOUNDATION WILL THEN CONSIDER THE REQUEST, APPLYING REASONABLE STANDARDS AND GUIDELINES.
