ResidentialDuring the year, 253 youth were served in our residential services. Services are provided to both boys and girls for treatment in juvenile delinquency, sexual offenses, substance abuse, and other mental health and behavioral issues. Clients and families reported positive results, 97% were satisfied with the social outcomes, and 96% were satisfied with their progress on individual treatment outcomes. 87% of clients discharged this year, successfully met their treatment goals.

Community-BasedDuring the year, 132 youth were served in our specialized community-based treatment programs in West Michigan. Our community-based services are intended to keep families intact, and help clients function better in their homes, schools, and communities. For FY 2016, 1,991 youth and adults were served in our community-based services in Wayne County and Eastern Michigan, those service types are foster care, substance abuse, intensive in-home treatment, diagnostics, assessments, autism services, and other psychological services. Some of the treatment outcomes from these programs are, 81% of youth reported attending school or working 1-year after completing treatment, 93% of youth did not report a psychiatric hospitalization for 1 year after completing mental health services.
