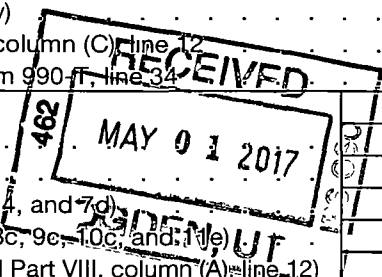

Form 990 Part X - In preparation of tax returns, tax positions are taken based on interpretation of federal, state and local income tax laws. Management periodically reviews and evaluates the status of uncertain tax positions and makes estimates of amounts, including interest and penalties, ultimately due or owed. No amounts have been identified, or recorded, as uncertain tax positions. Federal, state, and local tax returns generally remain open for examination by the various taxing authorities for a period of three to four years. The years 2011 through 2015 remain subject to examination as of September 30, 2015.

Income taxes are not provided in the accompanying financial statements since the Agency is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Code and similar state provisions. The Agency has evaluated the provisions of ASC Topic 740, Accounting for Uncertainty in Income Taxes. The Agency concluded that there are no significant uncertain tax positions requiring recognition in the Agency's financial statements. The Agency is not aware of any adjustments to the tax returns as filed, or is it aware of any claims for amounts owed from the taxing jurisdictions.

Form 990 Part VI, Section A, Line 10 - Review of Form 990. Community Action Agency's Form 990 is prepared by the Agency's Chief Financial Officer, who is a Certified Public Accountant, and reviewed by it's Chief Executive Officer. It is received and approved by the Agency's Finance and Audit Committee, and ultimately the full Board of Directors.

Form 990 Part VI, Section B, Line 15 - Review of compensation of Chief Executive Officer. The Agency's Executive Committee performs an annual evaluation of the CEO, which includes performance evaluation and compensation comparability. The Executive Committee then makes a recommendation to the full Board of Directors.
