AARDA's education program focuses on public, patient, and physician education. The organization conducts public awareness campaigns, patient workshops and scientific meetings. AARDA publishes patient information and a newsletter and sponsors an award-winning website. The objective is to improve early and correct diagnosis of all autoimmune diseases. This year AARDA sponsored several public forums, and organized or supported several scientific meetings for cross fertilization of research information and education of patients and the public. Additionally, AARDA provides a social platform for patient support. AARDA continued to offer an educational curriculum targeted toward grade school age children. The objective was to educate the student's family on the "family connection" in autoimmune diseases with the objective to help families understand that multiple autoimmune diseases run in families. AARDA continues focus on advocacy thru representation at the WHO meeting, many capitol hill briefings and issues surrounding patient care and treatment with the era of the Affordable Care Act. AARDA continues to facilitate the National Coalition of Autoimmune Patient Groups and held an autoimmune summit focusing on research, advocacy and other issues facing patients including results of a survey on the subject of fatigue which has long been ignored and or misunderstood by the medical community. A paper was published carrying these highlights.
