THE WISCONSIN EARLY CHILDHOOD ASSOCIATION'S (WECA) CHILD AND ADULT CARE FOOD PROGRAM HELPS PAY FOR NUTRITIOUS MEALS AND SNACKS SERVED TO CHILDREN IN REGULATED FAMILY CHILD CARE HOME SETTINGS. THE PROGRAM PAYS A FIXED AMOUNT FOR EACH MEAL AND SNACK SERVED THAT MEETS THE U.S. DEPARTMENT OF AGRICULTURE'S (USDA) STANDARDS. FAMILY CHILD CARE PROVIDERS ARE TRAINED IN PROGRAM RULES AND PROPER NUTRITION FOR CHILDREN. DURING THE YEAR, WECA SERVED 910 FAMILY CHILD CARE PROVIDERS THROUGHOUT WISCONSIN.

THE T E A C H EARLY CHILDHOOD SCHOLARSHIP AND REWARD STIPEND PROGRAM PROMOTES PROFESSIONAL DEVELOPMENT WITHIN THE CHILD CARE WORKFORCE THROUGH SCHOLARSHIPS THAT OFFER FINANCIAL SUPPORT TO PAY MOST OF THE COSTS OF TUITION, BOOKS, TRAVEL, RELEASE TIME, AND A BONUS AFTER THE STUDENT SUCCESSFULLY COMPLETES A SCHOLARSHIP CONTRACT, IN EXCHANGE FOR A COMMITMENT BY THE STUDENT TO REMAIN IN THEIR JOB FOR A SPECIFIED PERIOD OF TIME. WECA ADMINISTERS THIS PROGRAM UNDER CONTRACT WITH THE WISCONSIN DEPARTMENT OF CHILDREN AND FAMILIES (DCF) WITH FEDERAL FUNDS FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES CHILD CARE AND DEVELOPMENT FUND (CCDF). DURING THE YEAR, WECA SERVED 1,668 EARLY CHILDHOOD PROFESSIONALS THROUGH THE T E A C H PROGRAM. THE R E W A R D PROGRAM IS A COMPENSATION INITIATIVE THAT AWARDS STIPENDS TO EARLY CHILDHOOD PROFESSIONALS BASED ON EDUCATION ALREADY ATTAINED AND YEARS WORKED IN THE FIELD. WECA ADMINISTERS THIS PROGRAM UNDER CONTRACT WITH DCF WITH FEDERAL FUNDS FROM CCDF. WECA PROVIDED 5,008 STIPENDS THIS YEAR.

WECA WAS A PARTNER IN YOUNGSTAR THROUGH JUNE 30, 2016. WECA HELPED EARLY CHILDHOOD PROFESSIONALS INCREASE THE QUALITY OF THEIR PRACTICES AND PROVIDED PARENTS WITH INFORMATION TO SELECT THE BEST CARE FOR THEIR CHILD. YOUNGSTAR HAS CREATED A CONSISTENT STANDARD OF CARE, RAISING THE LEVEL OF EARLY EDUCATION IN WISCONSIN. BY RAISING THE STANDARD OF CARE TODAY, CHILDREN ARE GIVEN THE OPPORTUNITY TO EXCEED STANDARDS FOR THE REST OF THEIR LIVES. YOUNGSTAR IS WISCONSIN'S CHILD CARE QUALITY RATING AND IMPROVEMENT PROGRAM. THROUGH YOUNGSTAR, WECA PROVIDED PROFESSIONAL DEVELOPMENT, COUNSELING, TRAINING, PROGRAM RATINGS, AND MICROGRANTS ACROSS WISCONSIN. WECA ALSO PROVIDED ONE-ON-ONE TECHNICAL CONSULTING WITH PROGRAMS IN MILWAUKEE COUNTY. THROUGH YOUNGSTAR CONSULTATION, WECA STAFF HELPED EARLY EDUCATORS CREATE QUALITY IMPROVEMENT ACTION PLANS TO IMPROVE LEARNING ENVIRONMENTS AS WELL AS BUSINESS, REGULATORY, HEALTH AND WELLNESS, AND EDUCATION PRACTICES. YOUNGSTAR MICROGRANTS PROCESSED BY WECA STAFF HELPED 1,796 CHILD CARE PROGRAMS GET THE EDUCATION RESOURCES THEY NEEDED TO PROVIDE HIGHER QUALITY CARE.
