OUR LARGEST PROGRAM IS EARLY HEAD START/HEAD START WHICH IS A CHILD DEVELOPMENT PROGRAM THAT PROMOTES SCHOOL READINESS AND PROVIDES COMPREHENSIVE HEALTH, NUTRITIONAL AND SOCIAL SERVICES TO ELIGIBLE BIRTH TO AGE FIVE PRESCHOOLERS AND THEIR FAMILIES. THE PROGRAM FOCUS IS ON HELPING PRESCHOOLERS DEVELOP THE EARLY READING AND MATH SKILLS THEY NEED TO BE SUCCESSFUL IN SCHOOL. 99% OF OUR FAMILIES RECEIVED PARENTING INFORMATION, INFANTS AND CHILDREN COMPLETED 367 MEDICAL AND 320 DENTAL EXAMS.
