Supporting Educators NYLC serves educators and out-of-school time practitioners through its programs and professional development offerings. We are directly impacting student engagement and academic achievement in 4 school districts through Districts in Action, our replicable, scalable, service-learning model that was created in partnership with the Education Commission of the States, National Center for Learning and Civic Engagement with Johns Hopkins University as the external evaluator. NYLC provides technical assistance to 5 state After School Networks directly impacting 40 organizations and indirectly impacting 400 youth. NYLC's The Generator School Network has 9,512 youth and adult members who have access to service-learning resources, tools, and peer networks. The National Service-Learning Clearinghouse is hosted by NYLC and is America's largest online library of service-learning resources. Through membership, webinars, trainings, and district support, NYLC served 15,483 people directly, impacting an estimated 550,000 youth indirectly.

Advancing the Field Nearly 900 youth and adults from across the United States and from 9 other countries attended the 27th Annual National Service-Learning Conference. The event logged more than 5,000 hours of volunteer service through onsite projects, a Day of Service, and other opportunities. NYLC communications reached more than 3.3 million people this year. NYLC's websites sustain a readership of 492,467 page views. The Generator School Network has 9,512 youth and adult members. The Leader Newsletter reaches more than 14,000 people semi-monthly, and the K-12 Service-Learning Standards for Quality Practice reached more than 2 million people through our websites, partners, and print publications.

Developing Young Leaders NYLC programs work directly with young people to develop their leadership skills. Our National Youth Advisory Council is comprised of 8 youth for the 2015-16 academic year. In 2016 they expanded their Youth4Education campaign, engaging more than 18,788 youth directly in addressing issues of education equity across the national and around the world. Our National Youth Leadership Training brought together 16 youth leaders from across the country who immersed themselves in learning how to make a powerful impact on issues of equity in their home communities. Through Project Ignition, 6 schools mentored 6 new schools to become leaders in saving teen lives through safe driving. More than 10,000 students were directly impacted in schools and thousands more in the communities where they live.
