FOOD SHELF WE HAVE BEEN FEEDING FAMILIES THROUGH OUR FOOD SHELF SINCE 1983. WE OFFER A CHOICE MODEL, ALLOWING CLIENTS TO SHOP FOR THEIR SPECIFIC NEEDS AND FAMILY PREFERENCES. WE ALSO EMBRACE NUTRITIOUS OPTIONS, WITH AN EMPHASIS ON INCREASED AMOUNT OF FRUITS, VEGETABLES AND WHOLE GRAINS. WE DISTRIBUTED ENOUGH FOOD FOR 646,187 MEALS IN THE LAST YEAR, A 4% INCREASE OVER THE PRIOR YEAR. ON A MONTHLY BASIS, WE SERVE NEARLY 600 UNIQUE HOUSEHOLDS WITH ENOUGH FOOD FOR APPROXIMATELY 7-10 DAYS, WHICH IS NEARLY TWO TIMES THE STATE AVERAGE. SNACK PACKS CONTAIN BREAKFAST AND LUNCH ITEMS FOR THE WEEKEND, WHEN CHILDREN DO NOT HAVE ACCESS TO FREE OR REDUCED MEALS AT SCHOOL. IN THE SUMMER OF 2014, MOBILE CHOICE, A HOME DELIVERY SERVICE, WAS LAUNCHED, SERVING CLIENTS WITH LIMITED MOBILITY DUE TO AGE, HEALTH AND/OR DISABILITY. CLIENTS ARE CONTACTED BY VALLEY OUTREACH VOLUNTEERS WHO REVIEW A SHOPPING LIST, FILL THE ORDER FROM THE WAREHOUSE AND DELIVER THE FOOD DIRECTLY TO CLIENT HOMES.
