Friends of PACER satisfies all of the following requirements to qualify as a public charity under the facts and circumstances test #1 Friends of PACER's percentage of public support for 2015-2016 is 31.33%, which is below the 33 1/3% required for the public support test. However, Friends of PACER's public support has consistently been well above 10% of its total support received #2 Friends of PACER does receive a large percentage of its support from the general public and it maintains a continuous and bona fide program for solicitation of funds. Friends of PACER generally hosts 2 public events each year, and has recently conducted a Phonathon campaign (late fall 2015) to generate additional broad-based support. Friends of PACER is pleased to have dedicated funders who have consistently supported and sponsored our events, however, it is our goal to further diversify our funding sources to maintain proper charity status. Friends of PACER continues to seek out new and diversified funding and all pertinent facts and circumstances indicate that Friends of PACER is publicly supported #3 Other facts and circumstances are listed here that indicate the organization is publicly supported. Friends of PACER received its 501(c)3 public charity status in 1988 and has operated as such since that time. Friends of PACER's programs support and provide information and assistance to parents of children and young adults with special needs. The two events generally held each year include a Run, Walk, Roll event and a Tasting event. Both events include ticket and registration payments as a portion of their revenue. However, the registration and ticket fees are intentionally priced at reasonable market prices. The Run, Walk, Roll registration includes a T-shirt and event registration. The Tasting ticket includes music and food and beverage samples. Therefore, most of the ticket prices are for 'value received and do not show' as donation revenue for tax purposes. While we also have 'sponsors' for the events, their payments are often over the 2% limit and do not fully count for public support. So, while these are public events, which attract over 200 participants each, and raise awareness and funds from the public, a portion of the funds raised are not considered for the public support test.
