CHILD CARE AWARE SYSTEM SUPPORT Unless noted, these numbers reflect a total of statewide and local program delivery of the Child Care Aware (also known as CCR&R) system for the DHS contract period July 1, 2015-June 30, 2016 Provide leadership and influence across the Child Care Aware system to create an integrated statewide structure organized for service delivery * The Coordinating Office held over 70 statewide and program-specific meetings for Child Care Aware staff, and attended 17 District planning meetings * Orientation sessions for any new staff in the system were held quarterly, and the Biennial Child Care Aware Institute was held in November of 2015 with over 100 field staff attended this two-day professional development opportunity * Listening Sessions occurred two times per year, providing an opportunity for any field staff working with the Parent Aware program to share their challenges and successes, and an annual "refresher" was held to support coaches in their understanding of evidence required for a Parent Aware rating Coordinate and deliver a system of professional development that raises the level of excellence in child care and early learning in Minnesota * Over 3,000 child care professional development sessions were offered to nearly 40,000 participants statewide through local Child Care Aware agency efforts * The Child Care Aware system offered the Minnesota Child Care Credential to 117 students in learning communities throughout the state of Minnesota including 27 Spanish speakers and 14 Somali language speakers These students were also reimbursed up to 75% of the cost of their credential through Race to the Top Funds (see next section) Provide all families with the resources and support they need to make informed child care choices * Parent Services staff completed the biennial Market Rate Survey, gathering price data from licensed child care providers to inform state child care assistance policy * Over 2,700 parents received child care referrals and information on quality care through phone referrals at the local CCR&R agencies, and the online search tool- parentaware.org was used by over 109,000 visitors This resulted in over 950,000 page views, with an average of 6 pages viewed each session * Parent Aware flyers featuring information about parent services were placed in several cultural community newspapers, with a total circulation of 60,000* Several new consumer-friendly resources and materials were added to the parentaware.org website to connect parents to other important community services to help their family

RACE TO THE TOP/PARENT AWARE RATINGS Parent Aware is a rating tool designed to help Minnesota parents find high quality child care and early learning programs that help children prepare for Kindergarten, including licensed family child care programs, child care centers, Head Start programs, and School Readiness programs Over 2,500 programs had a rating as of September 30, 2016 The program is led by the Minnesota Department of Human Services in coordination with the Minnesota Office of Early Learning Child Care Aware of Minnesota coordinates local-level implementation Parent Aware is also supported by a unique partnership with business and community leaders through Parent Aware for School Readiness and Greater Twin Cities United Way The following steps were taken by the Child Care Aware coordinating office with Race to the Top funds * The Coordinating Office built capacity within the Child Care Aware system to provide CLASS Coaching for Parent Aware participating programs, including the identification of "Coach Champions" from among the system staff * The Coordinating Office provided ongoing strategy and implementation support for the work of the Parent Aware recruiters In addition, e-blasts, newsletters, brochures, and Parent Aware information sessions were provided to the field and used to promote participation * Several "chat with a recruiter" events were held on our Parent Aware Facebook page, and two new videos featuring the provider/coach partnership in Parent Aware were produced and released through social media * The Coordinating Office is funded through Race to the Top funds to manage the Parent Aware Rating Team that provides final review and scoring for the Quality Documentation Portfolios submitted by providers pursuing a Star Rating This work includes rigorous processes to ensure reliability and consistency of ratings * New Parent Aware standards, indicators, and evidence for Rating of programs were developed this year and focus groups were held with providers as well as community stakeholders to help to refine the tools These changes will be implemented in July of 2017 * Race to the Top funds were also used to supplement the services related to the Child Care Credential (described in the previous section), T E A C H and CDA Scholarships, and Eager-to-Learn online trainings which are described in the following sections

DIRECT FINANCIAL SUPPORTS Because Minnesota depends on high-quality child care, Minnesota depends upon strong investments in care professionals Our scholarship and grant programs focus on sustaining child care professionals and supporting their growth The T E A C H Early Childhood Minnesota scholarship program (Teacher Education and Compensation Helps) is an education scholarship program for early care and education providers, Directors, and Trainers to attain higher education degrees, with the goal of increasing their competency, and reducing staff turnover by providing incentives to stay in the field In 2015-2016 * We awarded 137 new scholarships* 15% of these recipients were from communities of colorThe R E E T A I N workforce retention program both rewards quality and reduces turn-over in the field by providing grants to child care providers who have already graduated with at least a two-year associate degree or currently hold a Child Development Associate (CDA) Credential In 2015-2016 * We awarded grants to 185 providers* 8% of these recipients were from communities of colorThe Child Development Associate (CDA)/MN Child Care Credential Support Project offers financial support and guidance to child care professionals who are working toward their National Child Development Associate (CDA) Credential or the Minnesota Child Care Credential, including support for coursework towards the credential and payment for CDA assessment fees In 2015-2016 * We awarded CDA scholarships to 118 professionals* 65% of these recipients were from communities of color

General performance recommendations are captured in the Board minutes, and the salary increase forms are kept in the personnel files of the Executive Director. With support from a consultant through the Minnesota Assistance Project (MAP), the Network created a salary ranking methodology and a compensation structure form to assess each position in the organization. Once the total points were established, the range for each position was determined. In 2012-13, the agency contracted with an HR consultant to update these ranges, based on a combination of the Minnesota Council of Nonprofits salary survey, a national nonprofit survey, and a survey by Child Care Aware of America. In 2013, the work of an independent consultant was also utilized. The consultant also proposed adjustments to employees within the ranges based on length of service and track record in the current position.
