Reducing Diesel Emissions: During 2016, MARAMA celebrated the 10th anniversary of the Mid-Atlantic Diesel Collaborative, whose members work to reduce diesel emissions to protect public health throughout the Mid-Atlantic Region. With the support of Region III of the US Environmental Protection Agency, MARAMA hosted an informative meeting of the Collaborative in the Philadelphia area in May 2016. Stakeholders from throughout the region engaged in meaningful dialogue and learned about diesel emission reduction opportunities.

Throughout the year, MARAMA administered grants to reduce diesel emissions from dray trucks serving Mid-Atlantic ports and from construction equipment owned by small businesses. Projects completed in FY 2016 included repowering one engine on large construction equipment used in Allegheny County, PA, and replacing 20 dray trucks serving ports in DE, PA, and VA.

To help inform members of the Collaborative, MARAMA hosted 3 webinars. Webinar topics included: cost effective methods to reduce ozone and greenhouse gasses via controlling NOx emissions from heavy duty vehicles; assessing the air quality impacts of vessels and port activity at the Port of Savannah; and heavy duty technologies' role in meeting future emission reduction goals.

Organizing and Supporting Training Opportunities: In FY 2016, The Mid-Atlantic Regional Air Management Association, Inc. MARAMA organized and presented 10 on-line webinars with over 900 participants attending. The webinars covered topics including: Introduction to Modeling, Clean Air Act, Excel Pivot Table, EMF Showcase, MySQL and MOVES, MARAMA Training Program Overview, Oil and Gas Storage Vessel Inspection and Enforcement Strategies, Forecasting Future EGU Emissions Using ERTAC, and Overall Scope of SEARCH Projects. 65 MARAMA members also attended 14 national and regional conferences and meetings with support from MARAMA.

**Form 990, Part III, Line 4c - Program Service Accomplishments**

Improving and Updating the Regional Emissions Inventory: In FY 2016, MARAMA helped member agencies work together and collaborate with nearby states by updating the 2011 regional inventory of air pollutant emissions to include improvements requested by states. To estimate future emissions, MARAMA projected 2011 emissions to 2017 using a new, more flexible Excel-based tool for development of inventory growth factor created for MARAMA under a contract with CSRA. Growth/control factors for the year 2023 were also developed using this new tool. The 2023 growth/control factors were provided to USEPA and used by them to estimate 2023 emissions based on the 2011 inventory.

Also in FY 2016, MARAMA continued developing the cloud-based Emissions Modeling

Framework (EMF) to house the emissions inventory, identify and correct issues with the data, create specific files for special projects, apply growth and control factors, and transmit data to regional modeling centers. MARAMA provided training on use of the EMF including a two-part MySQL webinar series and facilitated focus groups to help member agencies use the tool to analyze emissions.

MARAMA participated in an inter-regional workgroup to improve emissions data for Electricity Generating Units (EGU). The workgroup has developed a tool to project EGU emissions that integrates data from a number of nationally recognized sources, including the Energy Information Agency (EIA), state agency permitting information concerning unit controls and operation, USEPA Clean Air Markets Division (CAMD) hourly EGU emissions data, and North American Energy Reliability Corporation (NERC) peak power estimates. As part of the workgroup, MARAMA manages ongoing operation of the tool to prepare future projections of EGU emissions.

MARAMA organized frequent conference calls and webinars to coordinate preparation of the inventory, provide training on the use of the EMF, and provide organized feedback to EPA on issues related to emissions, particularly with respect to on-road mobile sources and oil and gas operations. MARAMA participated on several national work groups to improve the state-of-the-art for emissions inventories.
