Of the 186 children served by Early Head Start, 83% lived in families with incomes below 100% of poverty and 13% lived in families with incomes between 100% and 130% of poverty, 1% received public assistance, 1% were in foster care and 1% were homeless. Head Start served 16% of children with disabilities. Early Head Start served 14% of children with disabilities. Head Start and Early Head Start classrooms were accredited by the National Association for the Education of Young Children (NAEYC) during the program year.

It's purpose is to make the homes of low-income clients more energy efficient, thereby reducing clients' fuel bills and increasing their comfort. The program also provides important health and safety services to the clients it serves. During the 2016 fiscal year, a total of \$1,278,736.38 was expended to weatherize 103 homes in UDMO's 12-county service area. The average per home was approximately \$12,415, in addition 10 homes were deferred for a total spent of \$6,300 and 2 homes required re-work for a total spent of \$1,010.39. LIHEAP - The Low Income Home Energy Assistance Program was established to help low-income Iowa homeowners and renters pay for a portion of their primary heating costs for the winter heating season, to encourage regular utility payments, to promote energy awareness and to encourage reduction of energy usage through energy efficiency and client education. The assistance is based on household income, household size, type of fuel and type of housing. Applications for assistance are taken from October 1 through April 30 at each of UDMO's county outreach centers. During fiscal year 2016, UDMO provided LIHEAP assistance to 5,630 households in UDMO's 12-county service area for a total spent of \$2,660,810, in addition crisis assistance was provided to 301 households for a total spent of \$154,779.01.
