Ethanol - Missouri Corn Merchandising Councils ethanol programs goals for this year were to dispel myths, Increase awareness of ethanol's safe use and expand ethanol use via infrastructure. This year alone we started Dispensing e15 for the first time in Missouri thanks to help from USDA BIP program. This is an increase blend of 5%. One local retail station in north Missouri increased his total ethanol sales by 25% just by adding e15. In our goal to dispel myths we worked with Crappie Masters All American Tournament trail and NASCAR to be able to talk to consumers as well as conservationist and boaters to give them facts as well as show them the performance of ethanol when used. To increase awareness of ethanol's safe use we worked with engineers from the auto manufacturers to do testing on higher ethanol/high octane blends in high compression engines of the future. We were also able to work with one of the top suppliers of fuel pumps to upgrade every pump to UL87A certification which allows the pump to dispense all the way up to E25. This will help long term with infrastructure to allow higher ethanol blends which in turn increases corn gnnnd which is our goal to help farmers find more corn uses
