Information and referral services to other federal, state, local and private programs and services are provided to individuals to meet their needs more effectively. Community service programs promote self-sufficiency by identifying the participants goals, the activities and resources needed to reach those goals, and the timeline for doing so

Food Program The food program for 60's Plus Dining, offers persons age 60 and above, a balanced meal to help senior adults remain healthy and independent through good nutrition. The program provides free and reduced meals to elderly individuals in both a congregate and home delivered setting. Dining sites are located in 31 communities. 60's plus dining served 174,617 eligible meals in fiscal year 2016. Under the food program for Early Childhood, children enrolled in the program receive funding for a nutritious and balanced breakfast, lunch, and snack
