The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. AFBIU is exempt from federal income tax under IRC section 501(c)(3), though it is subject to tax on income unrelated to their exempt purpose, unless that income is otherwise excluded by the Code. AFBIU has processes presently in place to ensure the maintenance of their tax-exempt status, to identify and report unrelated income, to determine its filing and tax obligations in jurisdictions for which it was nexus, and to identify and evaluate other matters that may be considered tax positions. The tax years ended September 30, 2016, 2015, 2014 and 2013 are still open to audit for both federal and state purposes. The organization has determined that there are no material uncertain tax positions that require recognition or disclosure in the financial statements. Schedule D, Part XI and XII AFBIU does not receive standalone financial statements, its operations are consolidated with an affiliated organization, The Haron Dahan Fund. The Parts XI and XII reconciliation on Schedule D tie back to AFBIU's financial information within the audited financial statements and not to the consolidated number.
