The Foundation also provided lending and building loan services to Warren Memonal Hospital. Interest expense paid by the Foundation relates to payments on building and equipment loans which were taken out by the Foundation in prior years to assist the hospital with needed building and equipment improvements and upgrades. In 2016, Warren Memorial Hospital paid the Foundation an amount equal to the interest expense paid by the Foundation on the loans. The amount paid by the Hospital to the Foundation is included in interest income on page 9 of the Form 990.
