## Part III: What is the organization's primary exempt purpose?

Our mission is to rescue homeless and stray cats locally and the surrounding areas by paying for veterinary care and services, providing small grants to animal rescue groups, and managing the size and health of feral and stray cat colonies, particularly in low income neighborhoods where resource is limited.
