Applicants are required to submit an extensive application and three letters of recommendation. The applicants are scored in six areas: 1) Financial need; 2) Academic achievement; 3) Involvement in the Quarter Horse industry; 4) References; 5) Leadership and Communications Skills; 6) Membership. The committee selects those with a genuine interest in the equine. The selection process is designed to prevent discrimination. Recipients of equine research grants submit applications to the American Quarter Horse Association's Research Committee for evaluation during the Association's annual convention. The committee evaluates the applications and research projects. The Foundation assists in funding the selected applicants. The Professional Horsemen's Crisis Fund provides financial assistance to applicants who must be AQHA members in good standing and also be members of the AQHA Professional Horsemen's Association. In evaluating evidence of financial need, consideration shall be given to the following criteria: annual gross family income, annual net family income, number of children or other dependents comprising the family of the recipient, availability of insurance, alternate sources of income, and severity of the disaster, hardship, or illness. Recipients will be selected by the Crisis Fund Committee, which consists of members from both the Foundation Committee and Professional Horsemen's Council. America's Horse Cares Grant provides financial assistance to organizations that offer equine-assisted activities and therapies that inspire or improve the quality of life of individuals with emotional, physical, and cognitive disabilities. The eligibility requirements are: organizations utilizing horses to provide equine-assisted activities and therapies to challenged or special-needs individuals; funding requests must be for support or enhancement of programs in existence for a minimum of three years; must be exempt organizations under 501(c)(3) of the Internal Revenue Code; funding must apply directly to the cause with no funds used for administration or fundraising costs. Recipients will be selected by the American Quarter Horse Foundation's Board of Trustees. The Verdugo International Horsemanship Camp is designed to strengthen horsemanship skills in international affiliate countries. Camps assist international horse enthusiasts develop skills in basic horsemanship, use of equipment, behavior modification of horses, nutrition, first aid, and veterinary care. Each year accredited universities with a structured equine sciences program submit their proposal to conduct an educational clinic for international horse enthusiasts. Proposals are submitted by the named university to the AQHA Chief International Officer and are reviewed by an AQHA-appointed selection committee.
