Advocacy and Organizing NARAL Pro-Choice America Foundation works at the national and state level to effectively use grassroots power, communication strategies, and our policy prowess to push government to protect and advance reproductive freedom and abortion access. With 1.2 million member-activists in all 50 states, NARAL has a network of mobilized, organized supporters ready to take action. In FY16, we -Mobilized over 100,000 people to demand that presidential debate moderators #AskAboutAbortion and get candidates on the record on how they would address the abortion access crisis, working with allies such as CREDO and Open Debate Coalition. The sustained petitions, social media chatter (over 190 million Twitter impressions), and public pressure resulted in Hillary Clinton addressing the issue, generating national headlines and discussion. After months of hard work, thousands of NARAL members celebrated a huge victory when Chns Wallace finally heeded their call to #AskAboutAbortion during the third and final debate. -Put reproductive freedom and the abortion access crisis on a national stage with our #DoYourJob campaign, which organized and mobilized tens of thousands of supporters to demand officials hear from President Obama's Supreme Court nominee, officials had said point-blank they didn't want to move forward because of abortion. We leveraged this situation to show the public how critical courts are to these rights with a c3 radio ad campaign and collected more than 200,000 petition signatures with our allies. We also generated visibility by dispatching Founding Father Ben Franklin (aka NARAL member John Robinson) to follow Sen. Chuck Grassley during his Iowa town hall meetings, imploring him to #DoYourJob. Mr Franklin was on the front page of seven Iowa newspapers and in The Washington Post. -Invested deeply in state-level organizing, tapping into the 7 in 10 who support legal access to abortion in key states where we can have an impact. We added offices in Iowa and Nevada, and took our vision of a Blueprint for Reproductive Freedom to these states and others to grow our base, such as Missouri, Washington, and Massachusetts, as well as Tennessee, Pennsylvania, Colorado, and Minnesota. Using canvassing, conversations with citizens, and digital strategies-including tablets for better data capture and to show videos at the door-we strengthened the foundation needed to push back against regressive restrictions and support expanded access in the years ahead. -Held officials accountable for using the outbreak of Zika, which can cause serious birth defects, to again attack reproductive freedom and go after clinics. Knowing what was at stake, including critical funding for research and prevention, NARAL mobilized the 7 in 10 while leading the messaging and polling to call out opponents for grandstanding, exposing their real agendas-to control women's reproductive choices, even at a cost to families. We launched a national accountability campaign that included ads calling out officials for inaction, as well as polling that showed Americans reject the anti-choice opposition's failed strategy. -Pushed back against discrimination by working with our CAARE Coalition allies to shine a spotlight on the Hyde Amendment, using the 40th anniversary to educate the public on the dangers of Hyde and call out anti-choice opponents for attempting to expand and entrench this discriminatory policy, which disproportionately hurts low-income women. To highlight this unfortunate anniversary and reach new audiences, we leaned into our digital and organizing work by hosting a Facebook Live interview with The Huffington Post, launched and circulated an engaging video looking at the dangers of Hyde and what a future without Hyde could look like, and ran op-eds in Morning Consult about Hyde, its harms, and what the movement is doing, as well as a second one on Medium featuring real people impacted by the policy.

All Access Served as fiscal agent to and collaborated with over 100 allies as part of the All Access Coalition to create the All Access Day of Action. With events in 35 cities, including the anchor event in Cleveland that featured Jessica Williams, Leslie Jones, Sia, and Natalia Lafourcade, All Access created a culturally centered opportunity for the 7 in 10 Americans who support legal access to abortion to become engaged and activated on this issue.
