Used clothing drive Beginning in October area law firms, corporations and other entities with ties to the Washington DC legal community have their employees donate used clothing. The clothing is collected by each participating entity and assembled at the organization's sorting site during the first weekend of December. Volunteers assist with the sorting of donated clothing, the fulfillment of clothing requests from area shelters and similar organizations, and the delivery of requested clothing to facilities. The entire process is completed during a three-day weekend

New clothing purchases The organization purchases socks, underwear, hats, gloves, sweats, jackets and other items from wholesalers and donates these items to Washington DC area homeless shelters and similar organizations. Donations are made primarily during the late fall and winter, in order to allow shelters to provide warm clothing to the homeless population they serve. Funds for the purchase of such items are collected from individual and corporate donations made throughout the year, including the winter Clothing Drive and a "Battle of the Law Firm Bands" contest each summer

The new treasurer who was responsible for preparing the returns (and who is acting without compensation and in his private capacity, and who is neither an accountant nor a tax lawyer) was also new to the organization and therefore unfamiliar with certain of the organization's practices and all the organization's financial records. While the organization's records are well-kept, they are not necessarily kept for the sole purpose of easily completing a tax return, and it took a significant amount of time for the new treasurer to familiarize himself with the organization's fundraising efforts, the organization's financial records, and the organization's prior-year tax returns. This wholly accounts for the late filing of these returns.
