1 The Foundation For Middle East Peace (FMEP) is a Nonprofit organization dedicated to informing Americans about the Israeli-Palestinian conflict and assisting in a peaceful solution that brings security for both peoples. The report on Israeli settlement in the occupied territories, published bimonthly by FMEP, provides up-to-date information on Israel's settlement policies as well as the ongoing negotiations with the Palestinians over the future of the West Bank, Gaza Strip, and Jerusalem. The Foundation also has a media outreach program. The Foundation shares data and analysis concerning settlement activity and related subjects with the media, scholars and others in the United States and abroad. Philip C. Wilcox, the Foundation's President, and Geoffrey Aronson, Editor of the Foundation's report, are available for public speaking and briefings to interested audiences. The Foundation also sponsors Israelis, Palestinians and others for visits to Washington to speak on the peace process.	0
2 The Foundation awards grants to organizations and activities that contribute significantly to a solution to the Israeli-Palestinian conflict. For example, grants have supported educational, humanitarian, public affairs, civil rights, and Palestinian-Israeli reconciliation activities, as well as humanitarian and development projects that meet the needs of victims of the current conflict.
