

Rates also vary greatly for suicide deaths, drug and poison deaths and prescription opioid deaths in these areas. Out of 133 localities in Virginia, Montgomery, Floyd, Wythe, Pulaski and Radford ranked 46, 47, 73, 85 and 101 respectively in health outcomes according to County Health Rankings, where one is the best and 133 is the worst. According to the 2011-2015 American Community Survey, the median household income for Floyd was \$48,005, Montgomery County was \$46,663, Pulaski County was \$47,495, Wythe County was \$41,360 and Radford City was \$29,912. There were 10%, 24.8%, 13.5%, 15.1% and 39% of residents living below the Federal Poverty Level in Floyd County, Montgomery County, Pulaski County, Wythe County and Radford City respectively. 10.6% in Floyd, 7.8% in Montgomery, 11% in Pulaski, 13.6% in Wythe and 8.7% in Radford did not have health insurance. Floyd Service Area, Montgomery County, Low Income persons in Pulaski, Radford City and Wythe South are classified as Medically Underserved Areas. Low Income areas in the New River Valley service area are also designated as Dental, Mental Health and Primary Care Health Professional Shortage Areas according to Health Resources &amp; Services Administration (HRSA). In the New River Valley, median household incomes are much lower than the median income statewide and Radford City has the lowest in the valley. Floyd County has the highest median incomes in the area closely followed by Montgomery and Pulaski Counties. 1. Pulaski County has the highest rate of children and adolescents that are eligible for the Free and Reduced Lunch Program at 53.67%, as compared to 41.2% for Virginia school districts as a whole. 2. Nearly half of students in Floyd and Wythe Counties are also eligible for the Free and Reduced Lunch Program. Many areas in the New River Valley were hard hit by the recession with increased unemployment rates from 2008 to 2011. Those rates have since started to decline. This Committee is made up of Board members of Carilion Clinic who do not have a conflict of interest with any of the executives being reviewed. This review was performed in November 2015 and September 2016. In addition, the Compensation Committee annually reviews the compensation philosophy for all executive leaders, including the CEO. This review included review of a comprehensive report from an outside compensation consultant specializing in healthcare organizations for select positions and the prior year's report on all of the reviewed positions. The reports reviewed by the Committee included a detailed comparison of total compensation and each element thereof, including base salary, bonuses and other cash compensation, and benefits, including deferred and retirement benefits. Compensation was compared to both a national and regional peer group of organizations similar in size and structure to the organization, the list of which was reviewed by the Compensation Committee. The Compensation Committee maintained detailed minutes of its meetings, setting forth the deliberations and decisions of the Committee regarding the compensation of these executives.
Part I, Line 4b	Select members of management participate in a Pension Restoration Plan. This Plan provides a benefit equal to the normal retirement benefit that would be payable to the participant were it not for the Qualified Plan's legislative restrictions on compensation and payable benefits, less the actual benefits under the Qualified Plan. Entitlement to benefits and consequent lump sum payment occurs upon attaining age 65 while employed by Carilion Clinic, disability, or 24 months following certain qualifying separations from service. Upon the death of the participant, the plan shall pay the participant's beneficiary according to plan terms. Select members of management participate in an Executive Flexible Benefit Plan, in which an allowance is provided to the participant for use in obtaining certain insurance benefits. The allowance is determined annually as a percentage of salary at Carilion Clinic's discretion. The amount of allowance in excess of elected benefits is credited to a capital accumulation account (CAA) with a deferred vesting date of at least two years from the first day of the plan year. The CAA shall be distributed in a lump sum upon vesting while employed, disability, or 24 months following certain qualifying separations from service. Upon the death of the participant, the plan shall pay the participant's beneficiary according to plan terms. Select members of management participate in a Defined Contribution Supplemental Executive Retirement Plan (DC SERP) in which the employer at the discretion of Carilion Clinic's Compensation Committee makes a contribution to an account established on its books for each eligible participant. If a participant ceases to be a participant prior to the vesting date, the account shall be forfeited. A lump sum distribution shall be made upon the participant's vesting date, death, or disability. Payments to listed persons during the calendar year under these plans included the following: Nancy Howell Agee \$ 141,071; Donald Lorton \$ 130,613; Melina Perdue \$ 29,590.
Part I, Line 7	The organization pays annual bonus compensation to management based on scorecard performance. While the scorecard contains a formula as a basis for determining overall performance, senior managers have discretion to include additional elements in their assessment of managers reporting to them.
