WEIR HIGH SCHOOL SCHOLARSHIP FUND**

- I. Purpose: The purpose of this scholarship is to assist individuals to be able to pursue an education at a post high school technical school, college (2-year or 4-year,) Community College, university, or accredited trade, industrial, or technical institution.
- II. Value The sum of the scholarship(s) will be not less than \$1,000, or may be a greater amount, as determined by the Trustees.
- III. Qualifications:
1. Recipient(s) should be a person(s) of high integrity, moral standards and ethical behavior.
 2. It is preferred that the recipient(s) participated as a member(s) of a Weir Senior High School sports program.
 3. The recipient(s) must be either a graduating senior(s) of Weir Senior High School or a previous-year recipient of an award from this scholarship trust.
 4. The recipient(s) should have demonstrated a good academic achievement and the ability to succeed at an institution of higher learning.
 5. Financial need should exist so that the awarding of the scholarship shall make a difference as to the recipient's(s') ability to pursue a higher education.
 6. Grades are important, but shall not be the sole or overwhelming determinant in making the award(s). Great importance shall be given to the factors previously mentioned above.
 7. It is not necessary that the student(s) attend a four-year college or university, junior college, or community college.
