MFLTD began operation in December 2014, at which time all liabilities and assets of MFRRG were legally assumed by MFLTD except \$8,000,000 which was transferred to the Bishop's Charitable Fund, an affiliate of the Roman Catholic Diocese of Wheeling/Charleston. The Hospital is also the sole member of the Medical Park Foundation ("the Foundation") which raises contributions solely for the use of the Hospital controlled entities. The purpose of the Foundation is to cultivate philanthropic support for patient care services, improve hospital facilities, support the uncompensated care program, and support community outreach programs. The Hospital is also the sole member of Wheeling Pediatrics, LLC (WP) and Women's Health Services (WHS). However, there are no assets nor activity for either of these legal entities as of and for the years ended September 30, 2016 or September 30, 2015. The Hospital also owns two holding companies, WH Holdings I, LLC (WHH I) and WH Holdings II, Inc (WHH II). WHH I and WHH II, Inc are single member limited liability companies of Wheeling Hospital, Inc. These holding companies may be used for any future endeavors that might be undertaken and capitalized by the Hospital outside of the covenants and agreements governing the US Department of Housing and Urban Development (HUD)-insured mortgage. As of and for the year ended September 30, 2016, there were no assets nor activity for WHH I.
