AT THE SEPTEMBER 3, 2015 MEETING OF THE BOARD OF DIRECTORS, THE BOARD SUSPENDED THE PATIENT SERVICES OPERATIONS OF THE ORGANIZATION, EFFECTIVE SEPTEMBER 18, 2015 AND PLACED ITS LAND, BUILDINGS, AND EQUIPMENT FOR SALE. ON OCTOBER 25, 2015, A PARCEL OF LAND WAS SOLD TO A LOCAL CHURCH FOR \$639,000. ON FEBRUARY 11, 2016, THE REMAINING LAND, BUILDINGS, AND EQUIPMENT WERE SOLD TO EPWORTH CHILDREN'S HOME FOR \$3,600,000. THE ORGANIZATION USED THE FUNDS TO PAY OFF THE OUTSTANDING NOTE PAYABLE. THE ORGANIZATION WILL CONTINUE TO SERVE THE COMMUNITY AS A PUBLIC BENEFIT, NON-PROFIT ORGANIZATION. RATHER THAN THROUGH TRADITIONAL PROGRAMS AND BRICK AND MORTAR SERVICES, THE ORGANIZATION WILL NOW CONTINUE ITS MISSION 'TO MEET THE UNDERSERVED MENTAL AND PHYSICAL HEALTH NEEDS OF CHILDREN, YOUNG ADULTS AND THEIR FAMILIES' THROUGH PROVIDING FINANCIAL SUPPORT AND ADVOCACY TO CHILDREN'S INITIATIVES IN SOUTH CAROLINA.
