Prevention Services. We provide funding and program support to local community organizations. We use established program models that can be implemented with fidelity so that we can measure our effectiveness and better ensure results. We focus on two generation strategies that work to build stronger families and keep children safe. We provided \$10,659,192 in grants and contracts to organizations providing services throughout the state.

4b (Code) (Expenses \$ 1,372,117 including grants of \$) (Revenue \$)
Program Development and Partnership Convening. Prevention is the work of many, and we are more effective when we work collaboratively, bringing together best practices, expertise, data and resources. No single individual, organization or government agency working alone can stop maltreatment and ensure that children are never injured. We have many key partners at the local and state level and often serve as the convening agent. We are a key partner in the Pay For Success initiative, involving facilitation of \$14 million between partners and we managed \$16 million in pass through funding.

Education and Professional Development. We work to give child-serving professionals the tools they need to best work with families in preventing child abuse, neglect and injuries. We offer a diverse set of learning opportunities from statewide conferences to specialized session on focused curriculum. We completed 45 trainings throughout the state to 1,449 participants, the majority of which were community prevention trainings working to prevent child abuse.
