ANIMAL SHELTERS - For the fiscal year ended September 30, 2016, the Atlanta Humane Society provided care and found homes for 9,200 animals surrendered to our facilities. In addition to accepting animals from the metropolitan Atlanta community, animals were transferred from other animal organizations throughout the Southeast to our shelters for adoption. AHS also actively participated in the rescue and rehabilitation of animals from puppy mills and animal hoarding situations. A total of 13,435 animals were spayed or neutered in an effort to combat the pet overpopulation issue in our community, including 6,800 surgeries performed as part of our low-cost, high volume spray/neuter program.

VETERINARY CENTER - The Atlanta Humane Society operates a full-service veterinary hospital providing affordable care for the public. For the fiscal year ended September 30, 2016, 5,960 animals received services at our veterinary center, with some of the services being rendered at low or no cost.

EDUCATION AND ADVOCACY - Staff and volunteers engaged in a wide variety of humane education initiatives over the past year, including tours of our facilities and classroom presentations, as well as adult presentations. These programs focus on the proper care and treatment of animals, the work done by the Atlanta Humane Society as well as the importance of programs such as spay/neuter in ending companion animal homelessness. Additionally, the Atlanta Humane Society is fortunate to have over 1,992 dedicated and active volunteers who assist in the day-to-day operations of the Organization and special events with nearly 120,000 hours being contributed throughout the year.
