CSBG : Total grant provided revenues of \$1,729,771. The recognized expenses totalled 1,728,406 (\$1,403,956 for program Expenses ; \$324,450 for management and General Expenses). All the funds received were spent. Deferred fixed assets of \$1,365 was removed from expenses. The program supports services that prevents homelessness and hardship due to delinquency in rental and utility expenses payments. It also provides educationl and life-skills trainings, such as budgeting and energy conservation. The CSBG grant generally supports most of the other programs and services of the agency. One Thousand Ninety- Nine (1,099) individuals were served in this fiscal year. The spent amount of \$1,365 was for fixed assets additionns.

4b (Code:) (Expenses \$ 4,320,275 including grants of \$) (Revenue \$ 4,343,984)

LIHEAP: The revenue amount of \$4,343,984 was received during the year. State funded energy program of \$45,050, was spent under this program, which brings the total expenditure to under this program to \$4,389,034(\$4,320,275 for program Expenses, \$68,759 for Management and General expenses). This is an energy program which targets eligible low-income households and assist them in the direct payments of their energy bills to avoid disconnections and hardship. During the year, 12,072 households were served.

4c (Code:) (Expenses \$ 16,086 including grants of \$) (Revenue \$ 21,712.)

YOUTHBUILD DOL: This is a \$902,150 three-year grant from September 2012 through December of 2015. AS of September 2015, a total of \$809,621 revenues and expenses had been received and spent. For this fiscal year a total of \$21,712 was spent in the last quarter of the three year program (\$16,086 for program Expenses and \$5,626 for Management and Adm. expenses). This amount was spent on closing-out the grant and on monitoring the progress of the youth who have graduated from the program.
