The 2016 NAVC Conference had over 17,000 attendees for its five-day conference. Attendees received world-class continuing education through interactive symposia, hands-on labs, lectures, and exhibitor booths. In connection with the NAVC Conference, the Organization received approximately \$252,000 of free use of medical equipment and donated supplies for labs and other educational activities.
