OVER 832 INDIVIDUALS WERE SERVED AND MORE THAN \$11.1 MILLION WAS PAID IN MISSION-RELATED WAGES BY THE RETAIL PROGRAM. THE STORES SELL A VARIETY OF DONATED MERCHANDISE (DONATED BY THE GENERAL PUBLIC AND BUSINESSES) TO THE COMMUNITY AT DISCOUNTED PRICES TO DIVERT ITEMS FROM LOCAL LANDFILLS AND SUPPORT GOODWILL'S MISSION TO PUT KENTUCKIANS TO WORK. 
