THROUGH VARIOUS EVENTS AND PROGRAMS THE AWARDS AND SCHOLARSHIPS PROGRAM CONTRIBUTED \$195,739 TO AUBURN UNIVERSITY AND AUBURN UNIVERSITY FOUNDATION FOR SCHOLARSHIPS. IN THE YEAR ENDED 9/30/2016, THE ALUMNI ASSOCIATION PAID \$218,506 TOWARD QUALIFYING ENDOWMENTS, LEAVING \$420,994 AS A PAYABLE TO THE AUBURN UNIVERSITY FOUNDATION.
