THESE CONTRIBUTIONS WERE USED TO PROVIDE FUNDING FOR PROGRAMS AND SERVICES ADMINISTERED BY GOODWILL OF THE OLYMPICS AND RAINIER REGION. THE FINANCIAL RESULTS PRESENTED IN THIS RETURN REFLECT DONOR UNRESTRICTED AND TEMPORARILY RESTRICTED CONTRIBUTIONS. AN UNRESTRICTED CONTRIBUTION IS AVAILABLE FOR USE WITH NO RESTRICTIONS OF TIMING OR USE. A TEMPORARILY RESTRICTED CONTRIBUTION HAS EITHER OR BOTH A TIMING AND SPECIFIC USE RESTRICTION TO BE MET BEFORE THE FUNDS BECOME AVAILABLE FOR USE. ON A DAILY BASIS, THE ACCOUNTING AND PURCHASING DEPARTMENTS OF GOODWILL OF THE OLYMPICS AND RAINIER REGION REVIEW TRANSACTIONS FOR POTENTIAL CONFLICTS OF INTEREST.
