Communities Unlimited, Inc. was founded in 1975 to provide safe, clean drinking water and sanitary wastewater disposal to individuals in low-wealth rural communities first in Arkansas and then throughout a seven state region: AL, AR, LA, MS, OK, TN, and TX. Today, CU is a community, economic development organization and a CDFI with approximately 50 full-time professionals providing intensive capacity building and capital to water and wastewater systems, entrepreneurs and communities throughout its region. CU's mission is to move rural and under-resourced communities in areas of persistent poverty in the South to sustainable prosperity.

4 A. Water, Wastewater and Solid Waste - CU works with small, rural communities to construct, operate and maintain public drinking water and wastewater treatment systems and address solid waste concerns through on-site technical assistance, training, educational workshops, publications, and financing. CU supports efforts in low-wealth communities to provide a safe supply of drinking water and the sanitary disposal of wastewater within an ever-changing regulatory environment. As a regional member of the national Rural Community Assistance Partnership, Inc., (RCAP), CU provides technical services to rural systems in our region. CU partners with communities to create better water and wastewater systems and solid waste solutions, along with increased local capacity to solve problems and leverage future opportunities. For the fiscal year 2016, CU provided onsite assistance to 364 small communities and rural systems comprised of more than 274,000 households. CU staff secured \$27 million in construction financing to improve community water and wastewater systems in 37 communities for more than 26,902 households. CU staff completed 98 formal training sessions attended by 1,497 community officials, board members and staff members of water and wastewater systems.

4 B. Access to Credit - CU's mission focus areas drive our lending with our financing primarily serving individual and community needs where traditional loans are either not readily accessible or available. CU's focus is on developing loan products that make a difference. Since success takes more than just money, CU couples its lending products with technical assistance and education to help borrowers succeed. CU has been a certified Community Development Financial Institution (CDFI) by the U.S. Treasury Department since 1992. This past year CU provided: 17 new loans totaling \$1.7 million to repair, upgrade, or expand water and/or wastewater disposal services in rural communities, impacting 7,019 families and businesses who rely on these critical services. 9 new loans totaling \$106,400 to help entrepreneurs start or expand their businesses. 53 new loans totaling \$134,500 to help low-income families living in the Colonias and along the Texas-Mexico border repair and improve homes they own. Assistance to 37 communities to help them secure financing totaling \$27 million to improve

4 C. Small Business Consulting & Community Sustainability

Small Business Consulting - Management consulting services are provided on-site and virtually to businesses to help them solve problems so they can grow and contribute to the economics base of their communities. In 2016 management consultants provided technical assistance to 178 small businesses, 18 of which were new businesses. 41 new jobs were created and 215 jobs were saved.

Community Sustainability focuses on strategic community business development through the integration and delivery of CU's products and services. This is accomplished through the facilitation and implementation of local communities' entrepreneurial ecosystem development strategies which focus on assisting small business development, community infrastructure capacity building, technology assistance and access to capital. The ultimate goal is transitioning target communities from surviving to thriving.
