Sales of 113,242 occurred during the fiscal period, accomodating 18,488 customers. The organization made 176 pickups of items donated during the fiscal year, besides the numerous donation drop-offs. Aid also includes individuals totaling 283 adults, 79 children, and 28 organizations helped at no cost to those individuals and organizations.
